ORDER

Provisional affiliation was granted for starting B.Ed. in Mahajubilee Training College, Mulloorkara, Thrissur during the academic year 2002-03 with intake of 100 students in the University Order read 1st. Continuation of provisional affiliation to the programme was granted up to 2014-15 in the University Order read 2nd.

The Principal, in the letter read 3rd, requested to grant continuation of provisional affiliation to B.Ed. during 2015-16 after remitting an amount of Rs. 1,40,000/- (Rupees One Lakh and Forty Thousand only) towards Administration and Affiliation fee (e-chalan No. 151447056 dated 25.05.2015).

National Council for Teacher Education, following the adoption of NCTE (Recognition Norms and Procedure) Regulations 2014, gave fresh recognition to the college to conduct B. Ed. of two-year duration with an annual intake of two units of 50 students each in the order read 4th from 2015-16. However, the Prospectus issued by the Directorate of Teacher Education, University of Calicut allowed the college only the intake of 50 students with the optional subjects and respective intake as seen in the following table.

The Syndicate resolved to follow the optional subjects and respective intake given in the Prospectus, to be the valid intake for the academic year 2015-16 according to the U.O. read 5th.

Granting continuation of provisional affiliation was delayed due to non-receipt of application in the CDC, and the I semester examination of B. Ed. was scheduled to be conducted in February 2016.

Considering the request and the urgent circumstances, the Vice-Chancellor approved granting continuation of provisional affiliation on the condition that the college would approach the NCTE for a corrigendum order and produce the same before continuation of provisional affiliation could be

considered for the next year. Therefore, continuation of provisional affiliation is granted to B. Ed. in six optional subjects with intake as seen in the table above in Mahajubilee Training College, Mulloorkara, Thrissur during 2015-16 on the condition that the college will produce a corrigendum order from NCTE with corrected intake before the end of the current academic session.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998 the institutions shall take appropriate measures for prevention of ragging in any form. Failure to prevent such instances, will invite appropriate punitive action including withdrawal of affiliation.

Affiliation granted is strictly provisional and only for the academic year 2015-16. The College has to apply for continuation of Provisional affiliation for the ensuing years, remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University. The list of colleges which were granted or which applied for continuation of provisional affiliation will be forwarded to the Controller of Examinations by the last week of June to ensure that examinations are not conducted in defaulting colleges.
